Acting Director, UCLA Ralph J. Bunche Center for African American Studies, Institute of American Cultures (IAC) 2020-2021

The Ralph J. Bunche Center for African American Studies serves as the intellectual hub for Black scholarship at UCLA by providing research opportunities for graduate and undergraduate students, supporting the research initiatives of affiliated faculty, fostering campus diversity, bridging the academy and community, and facilitating interdisciplinary collaboration. I served as Acting Director while the Director was on sabbatical leave. I oversaw existing research, programs and community-based initiatives, including securing an additional \$800,000 in external funding from a private donor for the Bunche Fellows Program (BFP). As Acting Director. I led the development, administration and/or implementation of the inaugural year, for four historic programs as part of the campus-wide, five-year Rising to the Challenge Initiative. First, I led the development and administration of the first, 2 of 5 cycles of the campus-wide process to select department/units who will receive FTE to hire tenure-track faculty members whose scholarly work — teaching, mentoring and/or research addresses the many facets of Black experience. Second, I led the administration of the selection of five inaugural Rising to the Challenge/Chancellor's Postdoctoral Fellows, who were placed in departments/units across the campus. Third, I led the development, administration and implementation of the inaugural Rising to the Challenge: Graduate Summer Research Fellowships for the Study or Support of Black Life, awarding 10 summer graduate fellowships for summer 2021. Forth, as a part of the Rising to the Challenge Initiative, I also served as chair of the inaugural Racial and Social Justice (RSJ) Seed Grants Program committee. This joint effort between the Institute for American Culture (IAC) and the Office for Research and Creative Activities (ORCA), developed and administered \$250,000 in seed research grants on racial inequities and racial and social justice (including campus climate issues) beginning in summer 2021.

Vice Chair for Graduate Studies, UCLA Department of Political Science, 2019-Present

The graduate program in the UCLA Department of Political Science consists of about 120 graduate students with an entering graduate cohort of about 18 to 21 students each year. Our large and intellectually diverse group of about 35 faculty offer coursework and opportunities for research in all of the major sub-fields of the discipline. Our graduate student curriculum facilitates intensive study in a number of cross-cutting areas – empirical and theoretical, contemporary and historical. As Vice Chair, I revamped the graduate admissions process in several ways to ensure that admitted graduate students would receive a full funding package with a stipend. Each year, despite the pandemic, we met our recruitment targets and goals. To address incoming and

continuing graduate student needs, I partnered with the UCLA Development Office to set up the Political Science *Graduate Student Greatest Needs Fund*, which offers small emergency stipends for graduate students. We launched the fund in May 2020 providing small grants (\$250-\$500 on average) to our graduate students in need. I expanded and revamped the Graduate Student Maven Program, which is a peer-to-peer mentoring initiative in our department. In addition to paid peer mentors in R statistical software, Math, Writing and Grants development, our office developed and funded two new positions to address graduate students' needs including: *Grad Office Maven*, developed as a liaison between our graduate students and the Graduate Office staff and programming, and the *International Student Liaison* (ISL Maven). The new ISL Maven helps to facilitate greater ways to understand and address the needs/concerns of international students in our department. I also redesigned and taught the course, *Introduction to Political Inquiry*, which helps entering Ph.D. students in Political Science to understand some of the great opportunities and unique challenges of graduate school, as well as to build connections with other graduate students and faculty members. The course consists of various research topics from UCLA faculty, as well as training sessions on Research and Implicit Bias, Human Subjects and Data Protection, Citation Management and Research, as well as Research Integrity and Ethics.
